After the repeal of Roe v. Wade: What does it mean for Black women

NNPA NEWSWIRE — "We're talking about another two or three hundred Black women who will die every year simply because they don't have access to abortion care because they can't make that choice. Most black women live in the south and this is where it is going to be more felt the deepest, I would say - but also, I'm thinking about poverty. The number one reason Black women, and all women, choose to have to get an abortion is because

they can't afford the child at the time. Most people who are choosing abortion already have children and they know they can't afford to have another child. So, this means that for Black women and Latinas in particular, the poverty rate is likely to increase by another 15 to 20 percent," said Linda Goler Blount, President of the Black Women's Health Imperative (BWHI), during an interview with Black Press USA.



fter the jolting decision by the U.S. Supreme Court to overturn Roe v. Wade on June 24, many women had to re-adjust their thinking regarding health care and personal decisions.

For Black women already dealing with historic and systemic challenges around access to health care and an increased rate of maternal death, the decision was more than personal.

Black women tend to live in states hostile to reproductive healthcare, Roe's overturn directly endangers Black women's lives by exacerbating pre-existing access restrictions. Forcing Black women to carry dangerous, potentially deadly pregnancies to term will worsen the ongoing Black maternal mortality crisis that sees Black women dying from pregnancy at three times the rate of white women," wrote Michelle Webb, Communications Director of the Black Women's Health Imperative (BWHI)

Additionally, many states have poor social services such as substandard prenatal care and high



child poverty rates. The economic know they can't afford to have factors will become an issue immediately in states that have laws that are put into place as a result of the Supreme Court's overturning of Roe. The reversal was a stunning change of almost half a century of landmark law on women's reproductive rights.

In an interview with Black Press USA the day after the decision, Linda Goler Blount, President of the Black Women's Health Imperative (BWHI), spoke on how the decision by the court will impact Black women specifically.

"I am worried about the sort of the internalization of that messaging and the trauma that will cause in this next generation but more to the point right now. What we will see over the next few vears is an increase in the maternal mortality rates for particularly for Black and brown women, but for all women, maternal mortality is projected to increase by 20 to 21 percent. For black woman it's 33 percent," Blount said.

The 6-3 ruling by the court ended the constitutional right to an abortion and there is now no federally guaranteed right to an abortion in U.S. States.

'The fall of Roe will also condemn Black women who seek abortions due to financial hardship to an inescapable cycle of impoverishment along with the poor health outcomes that accompany it. Roe was a significant step toward a more equitable society in which Black women had access to the autonomy and agency they have traditionally been denied," Michelle Webb added.

'By overruling nearly fifty years of legal precedent, the Court has turned the clock back on decades of progress made by Black women in America — and fanned the flames of a deadly public health crisis in the process," added Webb hours after the decision came down

All three of the Associate Justices appointed by former President Donald Trump, Neil Gorsuch, Brett Kavanaugh and Amy Comes Barrett, voted to overturn Roe.

As Trump court flexes power, **Clarence Thomas emerges as** spokesperson

rom striking down Roe v. Wade and weakening environmental protections and threatening to strike Times v. Sullivan, Supreme Court Associate Justice Clarence Thomas has a lot to say lately.

In the week after the Supreme Court took away a constitutional right for the first time in history, Thomas, 74, is emerging as a central character for the conservative members of the Supreme Court. After President Donald Trump appointed three conservative judges to fill the vacancies that Democrats were unable to convert on, Thomas now has plenty of conservative company.

After three decades on the Supreme Court and often being in the minority when opinions were released, suddenly Thomas' influence is large.

The 6-3 court represents the first time in decades that conservatives have control of the court which now has no moderate members to tip the scale one way or the other on close votes. As the decisions of the year are released, an expansion of gun rights in New York was part of the key decisions.

On June 30, Judge Ketanji Brown Jackson joined the court after a noon swearing-in ceremo-


ny. She takes the place of Associate Justice Stephen Breyer.

"They object on religious grounds to all available COVID-19 vaccines because they were developed using cell lines derived from aborted children,"Thomas wrote in an opinion on June 30. The notion that COVID-19 vaccines are somehow linked to fetuses is deliberate disinformation spread primarily by QAnon online. No COVID-19 vaccine in the United States contains the cells of fetuses.

"Justice Clarence Thomas confirmed many of our deepest fears about where this decision may lead: Taking aim at additional long-standing precedent and cherished privacy rights, from access to contraception and in-vitro fertilization to marriage equality," House Speaker Nancy Pelosi said of Thomas last week.

Many progressives have been targeting Thomas for criticism all week after the fall of Roe v. Wade after 49 years. Thomas is indicating more conservative moves by the current court are likely.

Roe decision could spur massive voter turnout during midterms

he failure of Congress to pass legislation like the John Lewis Voting Rights Advancement Act and the George Floyd Justice in Police Act have already frustrated African Americans and further dampened hope for a sizeable Black voter turnout during the 2022 midterm elections

But, with the U.S. Supreme Court overturning the landmark Roe v. Wade statute and effectively taking away reproductive rights, some believe voters are now galvanized and poised for a massive

showing in November.

'The Supreme Court's decision in Dobbs v. Jackson Women's Health Organization says abortion is not deeply rooted in our nation's history. In holding that, the decision calls into question other rights that we thought were settled, including the right to use birth control, the right to same-sex marriage, and more,"Vice President Kamala Harris said.

"The great aspiration of our nation has been to expand freedom. But the expansion of freedom is not inevitable. It is not something that just happens unless we defend our most fundamental principles. And not unless we elect leaders who stand up for those principles," Harris continued.

"The strength of our nation has always been that we move forward. We must now come together to show what kind of country we want to live in and reject the notion that our rights are up for debate."



Russ Feingold, the president of the progressive legal organization, American Constitution Society, said the decision marks the "first time that our highest court has taken away a constitutional right."

"But make no mistake, our courts will play a crucial role in the fight to restore federal abortion rights and protect state abortion rights," Feingold said in an email.

"If we're ever going to restore the constitutional right to abortion on the federal level, we must ensure that we have judges on every level of the bench that will protect constitutional rights," he stated.

Congressional Black Caucus Chairwoman Joyce Beatty (D-Oh.)

said the hands of time have again been turned back.

'The extreme right-wing Supreme Court majority's decision to overturn Roe v. Wade, the law of the land for 49 years that gave a woman the right to choose, will have far-reaching and painful consequences," Beatty stated.

'Moreover, in the midst of a Black maternal mortality crisis, restricting access to abortion care will disproportionately endanger the lives of Black Americans," Beatty asserted.

She continued:

"Let me be very clear: government-mandated pregnancy is not pro-life. It is pro-policing of women's bodies. In response to this unacceptable decision, I, along with members of the Congressional Black Caucus, are co-leading a letter to President Biden urging him to swiftly declare this unprecedented attack on abor-

judge sentenced former Minneapolis police officer Derek Chauvin to more than 20 years in federal prison for violating George Floyd's civil rights. Chauvin pleaded guilty to the charges in December and was ordered to pay restitution, according to CBS News.

Chauvin agreed to a plea agreement that required him to serve a 20- to 25-year sentence that would be completed concurrently with his state conviction, ABC News reports.

In April 2021, a jury found Chauvin guilty on three counts of Floyd's death, including second-degree unintentional murder, other convicted officers.



third-degree murder and second-degree manslaughter, after pressing his knee into Floyd's neck for more than nine minutes.

During the sentencing, U.S. District Judge Paul Magnuson demanded accountability from Chauvin, saying he "must be held responsible" for his behavior and for ruining the lives of the three

tion rights and access as the public health and national emergency that it is. We have seen what life was like pre-Roe v. Wade, and America cannot afford to go back."

There's a reason why the majority of Black adults believe that the Supreme Court has mostly taken rights away from them over the past 15 years, offered Alicia Garza, principal at Black to the Future Action Fund, a national organization dedicated to making Black communities powerful in politics.

We have seen this body gut the 1965 Voting Rights Act in Shelby County v. Holder, and now they are doing it to our healthcare," Garza remarked.

"Abortion bans aren't just about abortion - they are about power. They are about who has power, who doesn't, and who wants to keep others from gaining it," Garza demanded.

'The Republican Party claims to be about less government and more freedom, but that is a blatant lie. In this decision, the Supreme Court bowed to the real agenda of the Republican Party, which is to subvert the will of the many to serve the needs of a few."

Garza added that abortion is a racial justice issue, and the decision will disproportionately impact Black families and devastate our economic futures.

NY mom attacks cop with crutch, spits at police after son is pulled over

47-year-old Long Island woman has been arrested for allegedly hitting one police officer with a crutch she was using and spitting at others after they pulled her son over for driving with a suspended license, authorities said Tuesday.

Melinda Medina was arrested a day earlier, in Levittown, around 2 p.m.

According to detectives, officers stopped Medina's 20-yearold son on Hempstead Turnpike because he was driving a vehicle with an expired New York State inspection sticker and a suspended license. As they investigated, Nassau County cops say Medina showed up at the scene and start-

ed behaving aggressively toward police.

She was taken into custody after the attack and brought to a hospital for evaluation. While in police custody at the hospital, cops say Medina punched an officer in the face and damaged his body camera. Other officers suffered various injuries during the course of her arrest because she allegedly was so combative, police said.

Medina's son was issued some traffic tickets and released from the scene where he was pulled over, officials said. She is charged with assault, criminal possession of a weapon, criminal mischief, harassment and obstructing governmental administration.



Angry customer shoots 2 Subway workers killing 1 over 'too much mayo' on sandwich

had "too much mayo." The 36-year-old man has been arrested but not identified after shooting two women workers at a Subway restaurant in downtown Atlanta, WSB-TV reports. A 26-year-old woman was killed while a 24- yearold woman is recovering from her injuries.

The five-year-old child of the 24-year-old woman was also inside the restaurant at the time of the shooting. Police responded to the shooting at a Subway attached to the Circle K gas station in downtown Atlanta just after 6:30 p.m. Sunday. Authorities say the shooter was upset about the sandwich he received from the restaurant. "There was something wrong with the sandwich that made him so upset that he decided to take his anger out on the two employees here," police said. "What you're seeing behind

"Black women are the primary breadwinners of our households, holding our families together with less and less. Therefore, our economic well-being, including whether we can get an education, work, and earn money to support ourselves and our families, is directly tied to our ability to make decisions about our bodies," Garza asserted.

With protests at the Supreme Court and nationwide, the call for a massive voter turnout during the 2022 midterm elections has grown louder.

During the National Newspaper Publishers Association's (NNPA) national convention marking the 195th-anniversary celebration of the Black Press of America in New Orleans, leaders announced a get-out-to-vote campaign aimed at registering and mobilizing GOTV for 10 million more African Americans to vote in time for the 2022 midterms

"Let us take the lead and not be on the tail-end so we can show the present-day power of the Black Press," said NNPA Chair Karen Carter Richards, who publishes the Houston Forward Times.

"With Roe overturned, the stakes of this election have never been higher – Black voters will stand with Senate Democrats against Sen. Mitch McConnell and Republicans' agenda that would make abortion illegal and impose new, cruel, and punishing restrictions on women of color and their families," said Jessica Knight Henry, Deputy, and Chief Diversity and Inclusion Officer for

the Democratic Senatorial Campaign Committee.

Florida Democratic Rep. Val Demings said she's furious and disappointed.

'I am ready to fight," Demings declared in a statement.

"We won't go back. We must work relentlessly to preserve our right to choose and our right to privacy. We must protect Roe v. Wade in federal law."

The court's decision ends core protection for women to make their own health care decisions, Georgia Democratic Sen. Raphael Warnock stated. "It is a departure from our

Family's 4-yr-old drowns during swimming lesson parents seeking answers

*A Hephzibah, Georgia family is pleading for answers after the sudden death of a 4-year-old who died in June during a swimming lesson.

According to his parents, Dori and Walt Scott the young boy (Israel 'Izzy' Scott) was an amazing kid who was a huge fan of the Black Panther superhero and loved to play with his siblings, ages 11, 3, and 16. His mother Dori said they decided to take their son to the instructor, Lexie TenHuisen who is the owner of "Swim With Lexie" because the boy's older sister took lessons from her two years ago.

Dori explained that she was told she couldn't stay and watch the lesson because she might "distract the children." She said she understood because she's a hairstylist and knows that children can



act differently when their parents are around.

The first lesson went smoothly but during the second lesson on June 14, Dori Scott sat in her car waiting for the lesson to be over. Then she said a parent knocked frantically on her window. "She said, 'Come check on your baby," she told TODAY Parents. "I immediately lost it because I saw it in her eyes.

Teenagers fatally beat 73-year-old man with traffic cone in Philadelphia

he Philadelphia police are requesting the community's help in locating a group of teenagers who beat a 73-year-old man with a traffic cone on June 24, according to CBS3.

James Lambert was on his way home when he was surrounded by seven teenagers unprovoked and beaten with a traffic cone on the 2100 block of Cecil B. Moore Avenue around 2:45 a.m. The teenagers were caught on surveillance video in the neighborhood hitting Lambert with the cone and other objects and knocking him to the ground. Lambert tried to get away but was hit again. He later died at the Temple University Hospital.

The police are searching for four boys and three girls roughly between the ages of 13 and 17. One of the boys has a patch of blonde hair on his head of otherwise dark hair. Philadelphia Police Capt. Jason Smith called the beating "horrible" and "horrific."

"It's horrible, it's a horrific occurrence," Smith said. "Mr. Lambert proceeds to get up and he's

attempting to walk away from the group again, and at that time, you can see a female strike Mr. Lambert in the back with a construction cone.

Tania Stephens is Lambert's niece and she wants justice for her uncle, who she said was like a father to her growing up. She also questioned why the teens were out so late committing crimes.

"I just don't understand what's going on in our city," said Stephens. Where were the parents? I just don't understand how children that age, whatever, they look like they couldn't have been any older than 14. How are you out at 2 o'clock in the morning committing crime? I'm a senior and I'm not out at that hour. The parents, they need to turn their kids in. The kids need help. They need help."

According to CBS3 reporter Matt Petrillo, the city of Philadelphia is offering a \$20,000 reward for any information leading to an arrest and conviction of those involved. The police believe the teens could be involved in other crimes in the area but would not elaborate further.

- Will voters reward those who spread the lie or hold their representatives accountable? We need a new surge from idealists and reformers to overcome the cynics that put democracy at risk.

on Jan. 6 has detailed what at some level we already knew. Trump lost the election. He knew it. His advisers knew it. His Justice Department knew it. The courts confirmed it.

fraud. Trump lied — and continues to demand recounts of ballots in of the Voting Rights Act, which democracy. They assume that the lying to this day.

No one likes a sore loser, but Trump would not accept that he lost. He railed about fraud so often that he convinced his followers that the election must have been stolen. He used the false claims to raise a stunning amount of money \$250 million — for an election defense fund that was a fiction. He used the money for his political and personal purposes. He not only misled those who believed in him, he ripped them off. So it goes.

That's not the real scandal. We have had a sense about Trump for a long time. Even his supporters understood he was a scoundrel, they just mistakenly thought he was their scoundrel.

Those who got misled and The House Select Committee fooled aren't really the problem. The problem is the cynical politicians who echoed the lies - and knew better. They not only re-enforced the lies, they acted on them.

Across the country, Repub-There was no evidence of voter licans used Trump's lies not just the process. They blocked revival

various states, they used them to change the law in very specific ways. They made voting more difficult, particularly for working and poor people who live in urban areas. They reduced early voting days, ended voting on Sunday, limited voting places in urban areas, made vote-by-mail more difficult, demanded new forms of ID that discriminated against students and minorities, and more.

Second, they made the possibility of distorting the vote more likely. They got rid of non-partisan election officials and replaced them with partisans. They gave state legislatures greater power to overturn elections simply because they don't like the results, regardless of how the majority voted. By 2024, as many as 20 of the 50 states will run under election orders that are much more exposed to partisan manipulation.

Third, at the national level, they blocked every effort to reform used to enjoy bipartisan support. They blocked efforts to perfect the electoral system and protect it from partisan meddling. They blocked reforms that would make it easier to register, harder to gerrymander districts, and set national standards for the country.

The cynicism of these politicians is clear. They assume that Americans won't let issues of democracy define their vote. They assume that not only will they pay no political cost for undermining democracy, they will be rewarded for it. The Trump lies fuel the anger of the Republican base — and dismay those who oppose those lies. The former are more likely to vote; the latter more likely to be turned off.

Are these Republican cynics right? Pollsters suggest they are. Voters are concerned about the price of food and gas, jobs and the economy, crime, and other concerns that impact their daily lives. They assume the existence of

debates over reforms are questions of partisanship, not patriotism.

A likely result is that Trump's Big Lie may end up discrediting him, but not the Republican politicians who joined in echoing it and cowered before Trump's wrath. To date in the Republican primaries, those who stood up to Trump have not fared well, while those who kowtowed to him have done better.

That is where we are. The Jan. 6 Committee will prove its case: Trump lied and tried to overturn an election he knew he lost. Now voters have to decide. Will they reward those who spread the lie or hold their representatives accountable?

Many commentators say that the committee has put Trump in the dock. In fact, it is our democracy that is in the dock. Will it be defended or deformed? Will it end strengthened or undermined? We need a new surge from idealists and reformers to overcome the cynics that put democracy at risk.







Nelson Mandela International Day is marked around the world

Relison Rolihlahla Mandela, an iconic figure who fought South Africa's apartheid regime, was a human rights lawyer, a prisoner of conscience and an international peacemaker. And he was the first democratically elected president of a free South Africa.

In light of these accomplishments, the United Nations General Assembly designated July 18, his birthday, as Nelson Mandela International Day. It celebrates the idea that each individual has the power to transform the world and the ability to make an impact. In honor of his 67 years of public service, the Nelson Mandela Foundation and the U.N. ask that you spend 67 minutes of your time helping others.

In South Africa, celebrations start early at Mvezo, Madiba's birthplace. Chief Zwelivelile 'Mandla' Mandela, Nelson Mandela's grandson, addressed the community: "Madiba was outspoken in human rights, justice and peace. We continue to utilize his legacy as a voice for many oppressed nations around the world." He mentioned consultations about the "last colony in Africa – Western Sahara", as well as the case of the Palestinians, Kashmir, Yemen, Syria, and Ukraine.

Video of yet another police shooting of unarmed Black man debued July 4th weekend

People for the American Way presents new plan for police and law enforcement By Barrington M. Salmon and

- As millions of people across American prepare to celebrate "liberty and justice for all" on July 4th, 2022, yet another news story of a police shooting of an unarmed Black man was breaking nationally. The killing of fleeing Jayland Walker, 25, by Akron, Ohio Police officers, who reportedly shot him 60 times, is still under investigation while the officers involved have been suspended pending the results.

Police say the shooting occurred after a high- speed chase during which they say a shot came from the vehicle driven by Walker, a report that Walker's family and lawyer has called into question. Police also said they found a gun in the car. They claim he appeared to be reaching for his waistband as he fled. But why he suffered 60 wounds in the June 27 killing is still in question.

Police Chief Stephen Mylett said at a July 3rd news conference that reviews of body camera videos of 13 officers at the scene prompted more questions about Walker's death. As the video was released, protesters, led by the Akron NAACP, took to the streets, a familiar site in modern day America.

Akron police said they had tried to pull Walker over on a traffic violation and began the chase after he did not stop.

Meanwhile justice-seeking organizations continue to present ideas on ways to prevent unjust police shoots, disparated of unarmed AfricanAmericans. The continued scourge of police violence against African Americans is one of the most contentious issues in the nation. According to statistics provided by People for the American Way (PFAW), in 2021 alone, police officers killed at least 1,134 people, with African Americans making up at least 23 percent of those killed, despite being only 13 percent of the US population. Racism is at the core of policing in this country, from colonial-era slave patrols to the post-Reconstruction vigilantism of the Ku Klux Klan to "order maintenance" policing of the late 20th century, Ben Jealous and his research colleague Dr. Niaz Kasravi contend.

In the aftermath of national and global protests following the murder of George Floyd by a quartet of Minneapolis police officers in 2020, Jealous said PFAW partnered with Covington & Burling LLP, and the Avalan Institute for Applied Research and consulted closely with law enforcement and policing experts, social justice activists, elected officials, community leaders produce a blueprint for reducing police violence titled, "All Safe: Transforming Public Safety."

"We are very proud to unveil All Safe: Transforming Public Safety as a guide for local communities to take solutions to our public safety crisis into their own hands. Let's face it: the federal government has failed to act on meaningful public safety legislation," Jealous, president of People For the American Way and former president and CEO of the National Association for the Advancement of Colored People said in an exclusive press briefing for African American journalists. "Meanwhile Black and brown people are dying at the hands of police officers. This has to stop. We can seed true, nationwide change by putting the right tools into the hands of communities now and building on their success, to create an unstoppable movement for public safety transformation."

Jealous and Kasravi announced release of the report. Kasravi – founder and director of the Avalan Institute and editor-in- chief of All Safe – said the report provides concrete policy proposals for the transformation and implementation of public safety programs at the local level.


"We know that this. We know that it's time for a change because the tradition approach just hasn't worked. Right? For centuries, this country has relied on "tough on crime," over-policing, and law and order policies," Kasravi explained. "And more moderate reforms around training and recruitment, of course are necessary and needed, but they are not the answer, the foundational answer to a long-term change that we need. We are in America, the #1 incarcerator in the world with roughly five percent of the world's population but we have 25% of its prisoners because of centuries on overreliance on police and systems of incarceration ...

Jealous, echoed Kasravi's comments that described the report as "the most comprehensive vision for transformation of public safety in our country." He credited Ithaca, New York's three-term Mayor Svante Myrick with embracing the report's provisions and implementing many of the proposals on the ground and in real life.

"We have to build the criminal reform movement from the bottom up," said Jealous, a trained criminologist who grew up in a family in law enforcement.

He described the challenge of achieving meaningful change with America's mélange of police departments – 16,000 local individualized police departments – each agency with its own rules and regulations.

"I figured out when I was at the NAACP that about 85 percent of African Americans live in 500 of these jurisdictions which means when it comes to saving Black

lives, we really have to reform 3-5 percent of law enforcement agencies in the US," Jealous said.

Among the report's proposals is changing police departments to public safety departments led by civilians with half the department comprised of typically armed officer and the other half made up of unarmed officers who are social work experts catering to the needs of the drug-addicted, homeless and mentally ill.

"We don't train these folks because that's not what they're supposed to be doing," he said, referring to police officers ill-equipped to handle non-crime issues. "It's shoot to kill and everything else. It would mean 60 percent of the officers we have now, radically less numbers carrying guns."

Kasravi elaborated.

"This report is the most comprehensive report that we've been involved with or seen produced. It's a handbook for elected officials with a large range of policy options to respond to the public demand from police reform," she said. "There are two co-equal teams of armed and unarmed individuals. The public safety model is a win on all fronts: it reduces the risk of harm and armed encounters; people are treated more humanely; this addresses medical and psychological needs; puts less stress on officers; and increased trust in the community."

Kasravi said the model also saves communities more money and increases efficiency and effectiveness as communities move towards "the vision we all want." "It's a local fight in every jurisdiction, a fight police must take up. No size fits all. There are different models and ways to respond," Kasravi said.

The report presents facts and statistics which illustrate the current states of affairs and the challenges of effecting police reform:

Police violence disproportionately affects communities of color. In 2021, while Black people accounted for only 13 percent of the US population, 28 percent of people killed by the police were Black. Another 19 percent were Latinx.

Of the estimated 240 million calls made to 911 each year, studies have found that 90 percent of calls involve situations that are nonviolent before police are called.

Police unions have erected barriers to prevent removal for those officers accused of misconduct. At the state level, unions have passed police officer "bills of rights," which provide broad protections for officers which are not provided to other people in similar situations.

In addition, the report's researchers showed that over-policing is encouraged as police brass demand that officers meet quotas which is one evaluation tool. And that police recruitment strategies attract aggressive men and women.

"A comprehensive study analyzing the recruiting materials used by the 200 largest police departments in the United States found that: 42.7 percent contained some display of drawn firearms; 34 percent portrayed military-style weapons; 32 percent showed officers in tactical vests; and 27.7 percent depicted paramilitary policing units," the report said.

Key tenets of the report are to remove police officers from schools; eliminate unnecessary misdemeanors and fines and fees; and ending the use of "excess" military equipment by law enforcement.

Jealous said PFAW focused on small college towns, like Ithaca, New York, where supporters and those connected to or affiliated with PFAW coalesced around the police reform policy proposals. The bedrock of the report is to restructure, hold responsible, remove, and recruit as a means of change, all the while addressing "the underlying issues and concerns that shape the organization's public safety programs and make specific suggestions for transforming both how we think of public safety and our public safety programs."

Their focus, Kasravi and Jealous said, has been at the local level because they contend that while a system overhaul will only come when state and federal officials move on it, "at the local level, executive, legislative, and judicial authorities can take steps immediately to reduce police violence."

But as it has in the past, the post-Floyd effort to secure meaningful reform fizzled because of the lack of political will, raw, hyper-partisan politics and an unwillingness of national politicians to accede to the real demands of African Americans. Yet Jealous and Kasravi argue that even in the face of these and other challenges, it is imperative for the Black and brown communities most affected to devise new ways to confront, address and change the status quo as it relates to policing in America.

"It's time for a fresh approach to the delivery of public safety in this country, because the hard truth is that what we have been doing hasn't worked," Kasravi said. "We have some of the most highly armed police forces and the greatest rates of incarceration in the world. If those strategies worked, we should be the safest nation in the world. But we all know that's not the case. It's time to transform our approach, and this report offers a range of options for communities to do that – and to improve and save lives, starting now."

The release of the report coincides with People for the American Way kicking off it's "Big Ideas" Summit in Atlanta this week. Civil Rights leaders, grassroots activists, elected officials and faith leaders will gather from around the US and mayors and other local officials have the option of taking All Safe recommendations back to their own communities to implement them.

Remembering **Producer Bernard Belle, brother of Singer Regina Belle**

ultiple Grammy Award-winning Musician/Composer/ Songwriter/Producer Bernard Belle died Thurs., June 23, 2022 at Piedmont Atlanta Hospital in Georgia, at the age of 57. Belle's official cause of death was due to congestive heart failure, according to his sister and primary caretaker, Regina Belle, a Grammy Award-winning recording artist, who posted on her Facebook Page, "The smartest part of me has passed on. My brother, Bernard Belle was brilliant. Bernie, please help me to shine from heaven. I love you."

Born Nov., 12, 1964, to the late Judge Belle and his mother, Lois Belle, who now resides in Atlanta, Bernard Belle was born and raised in his hometown of Englewood, and the neighboring town of Teaneck, New Jersey. During the past seven years, Bernard had suffered from two strokes, and was later moved from Englewood, New Jersey to Signature HealthCARE of Buckhead, where he could be

close to his parents, daughter Asia Milner, and sister, Regina.

A world-class musician and songwriter/producer for multiple award-winning pop, R&B and gospel recording artists, including the late Michael Jackson and Whitney Houston, Bernard received his first career break in the 1980s, when Regina, who was performing as a background vocalist for the R&B group, The Manhattans, recommended him to join the group as the bassist.

A multi-instrumentalist (pianist, bassist, guitarist, drummer and vocalist), Bernard later became one of Black Music's most gifted and prolific creators; penning hits for Michael Jackson such as "Re-member the Time" "Privacy," and "Why You Wanna Trip on Me." He also produced records for Whitney Houston, Aaron Hall, Keith Sweat, and Al B. Sure! and Today, among numerous others.
