Largest-ever HBCU week coming to Walt Disney World Resort next month

LAKE BUENA VISTA, Fla. – High school students from across the Southeast and beyond will descend on Walt Disney World Resort next month for the largest-ever HBCU Week featuring a huge college fair, a parade of high-stepping marching bands, a fierce battle of the bands and a live ESPN broadcast.

A record number of high school students (more than 5,000) and Historically Black Colleges and University representatives (nearly 50) will take part in the weekend event, October 7-9, 2022, when more than \$10 million in scholarships are expected to be awarded, which would be another event record. Since 2017, more than 3,500 on-the-spot admissions have been offered, along with more than \$23 million in scholarships.

This is the first time in its fiveyear history that the HBCU Week Foundation is hosting its annual event at Walt Disney World Resort, which is expanding the foundation's ability to stage new and more high-profile activities for its attendees. As a result, this year there will be a parade of HBCU bands down Main Street, U.S.A. at Magic Kingdom Park; a battle of the bands at ESPN Wide World of Sports Complex along with the college fair; a live broadcast of ESPN's First Take show featuring HBCU Week ambassador Stephen A. Smith and show host Molly Qerim; and several Lunch and Learn seminars for students to gain educational and career insights.

Delaware State, Bethune Cookman, North Carolina A&T, Winston-Salem State and Alcorn

University will participate in the parade at Magic Kingdom and compete in the Battle of the Bands.

"We are pleased to share in the mission to highlight the rich history and cultural significance of HBCUs, creating educational and, ultimately, career opportunities for students," said HBCU Week Founder and CEO Ashley Christopher. "Hosting this national event at Walt Disney World Resort helps amplify the mission of HBCU Week, attracting more parents and students throughout the country to our events and helps make an even greater impact in fostering opportunities for thousands of students."

ongresswoman Barbara Lee (D-CA) applauded the Biden Administration's announcement on Wednesday of \$6 billion in new funding for the Global Fund at the Seventh Replenishment Conference during this year's United Nations General Assembly.

The United States is proud to be a founding member of, and the largest single donor to, the Global Fund to Fight AIDS, Tuberculosis, and Malaria (Global Fund). Started in 2002, the Global Fund is a unique financing mechanism that relies on a dynamic partnership among governments, the private sector, and civil society to fight

malaria in ways that contribute to strengthening health systems.

"Twenty years after we established the initial framework for the Global Fund, it has become a powerful force for change within the global health infrastructure, saving over 44 million lives from AIDS, TB, and malaria," said Lee. "I commend the Biden Administration's announcement of an additional \$6 billion in funding for the Global Fund and look forward to continuing to partner with the administration and our partners in the fight to save lives and see the first AIDS-free generation."

Bail Project helps people get out of jail, reunites families

Hundreds of thousands of individuals locked up in jails almost daily — many find it challenging to pay bail

s public support for criminal justice reform continues to build — and as the pandemic raises the stakes higher advocates remain adamant that it's more important than ever that the facts are straight, and everyone understands the bigger picture.

The U.S. doesn't have one 'criminal justice system;' instead, we have thousands of federal, state, local, and tribal systems," Wendy Sawyer and Peter Wagner found in a study released by the nonprofit Prison Policy Initiative.

Together, these systems hold almost 2 million people in 1,566 state prisons, 102 federal prisons, 2,850 local jails, 1,510 juvenile correctional facilities, 186 immigration detention facilities, and 82 Indian country jails, as well as in military prisons, civil commitment centers, state psychiatric hospitals, and prisons in the U.S. territories," the study authors said in a press release

With hundreds of thousands of individuals locked up in jails almost daily, many find it challenging to pay bail.

Recognizing America's ongoing mass incarceration problem and the difficulties families have in bailing out their loved ones, a new organization began in 2018 to offer some relief.


The Bail Project, a nationwide charitable fund for pretrial defendants, started with a vision of combating mass incarceration by disrupting the money bail system.

Adrienne Johnson, the regional director for The Bail Project, told NNPA's Let It Be Known that the organization seeks to accomplish its mission one person at a time.

"We have a mission of doing exactly what we hope our criminal system would do: protect the presumption of innocence, reunite families, and challenge a system that we know can criminalize poverty," Johnson stated.

"Our mission is to end cash bail and create a more just, equitable, and humane pretrial system," she insisted.

Johnson said The Bronx Freedom Fund, at the time a new revolving bail fund that launched in New York, planted the seed for The Bail Project more than a



decade ago.

"Because bail is returned at the end of a case, we can build a sustainable revolving fund where philanthropic dollars can be used several times per year, maximizing the impact of every contribution, Johnson stated.

In addition to posting bail at no cost to the person or their family, The Bail Project works to connect its clients to social services and community resources based on an individual's identified needs, including substance use treatment, mental health support, stable housing and employment.

Johnson noted that officials created cash bail to incentivize people to return to court.

Instead, she said, judges routinely set cash bail well beyond most people's ability to afford it, resulting in thousands of legally innocent people incarcerated while they await court dates.

According to The Bail Project, Black Americans are disproportionately impacted by cash bail, and of all Black Americans in jail in the U.S., nearly half are from southern prisons.

"There is no way to do the work of advancing pretrial reform without addressing the harmful effects of cash bail in the South," said Robin Steinberg, Founder, and CEO of The Bail Project.

"Cash bail fuels racial and economic disparities in our legal

system, and we look forward to supporting the community in Greenville as we work to eliminate cash bail and put ourselves out of business.

Since its launch, The Bail Project has stationed teams in more than 25 cities, posting bail for more than 18,000 people nationwide.

Johnson said the organization uses its national revolving bail fund, powered by individual donations, to pay bail.

The Bail Project has spent over \$47 million on bail.

"When we post bail for a person, we post the full cash amount at court," Johnson stated.

'Upon resolution of the case, the money returns to whoever posted. So, if I posted \$5,000 to bail someone out, we then help the person get back to court and resolve the case," she continued.

"The money then comes back to us, and we can use that money to help someone else. So, we recycle that."

Johnson said eliminating cash bail and the need for bail funds remains the goal. "It's the just thing to do. It

restores the presumption of innocence, and it restores families," Johnson asserted.

Financial fairness at risk with proposed TD Bank-First Horizon merger

s banks grow larger through mergers and focus on growing online and mobile services, serious concerns emerge on how fair and how accessible banking will be to traditionally underserved Black and Latino communities. In most cases, consumers and small businesses, alike view bank branch accessibility and convenience as key to serving their communities.

Consumer advocates currently are urging bank regulators to thoroughly examine a proposed TD Bank merger, particularly in light of the lender's record with home loans and overdraft fees.

Earlier this year, TD Bank announced its plan to acquire First Horizon Bank and its \$85 billion in assets and 417 locations, largely in the South. If approved by federal regulators, the merger would create the sixth-largest bank in America

TD Bank already has more than \$1.3 trillion in , 27 million customers and over 1,100 locations spread across 15 states and the District of Columbia. In Atlanta and Dallas, the bank does business as TD Ameritrade. Its largest number of branches by state are located in New York (367), Florida (355), and New Jersey (367).

According to its website, "Black experiences, in all their diversity, are at the heart of our drive for positive, sustainable change."

But as Sportin' Life, a character in the immortal folk opera, Porgy and Bess, said: "It ain't necessarily so." Indeed, TD's business record sends a different message.

Earlier this year, WHYY, the National Public Radio station serving the Philadelphia metro area, reported that in its region between 2018 and 2020, "TD Bank was more



likely to approve a mortgage loan for a low-income white applicant than a high-income Black applicant....

TD Bank had the lowest mortgage approval rate for Black applicants in its entire metro area. During this time, "the institution denied 20 percent of all purchase mortgages, but denied nearly 40 percent of all Black applicants," according to the data, which was charged customers overdraft fees culled from Home Mortgage Disclosure Act data. By comparison, the denial rate among white applicants was 20 percent."

a 2018 investigative article by Reveal News: "African American and Latino borrowers are more likely to get turned down by TD Bank than by any other major mortgage lender. The bank turned down 54 percent of black homebuyers and 45 percent of Latino homebuyers, more than three times the industry

averages." Then there's TD Bank's poor record on overdraft fees.

Just two years ago the Consumer Financial Protection Bureau (CFPB) entered into a consent order with TD Bank that provided \$97 million in restitution to 1.42 million consumers, and the CFPB charged the firm a \$25 million civil penalty. The bank had illegally without first obtaining their consent before enrolling them in its optional overdraft.

Overdraft fees often exploit A similar finding appeared in consumers' short-term cash needs. The vast majority of overdraft fee revenue comes from people with account balances that average less than \$350.

TD Bank's business model relies far more on overdraft fees than other large banks. While some of its peer institutions eliminated overdraft fees, TD charges a \$35

overdraft fee as many as three times a day.

Fortunately, consumer advocates are registering their serious concerns with federal regulators.

'TD Bank cannot serve the needs of low-income communities while insisting on maintaining this large stream of revenue that, by definition, depends on consumers who lack funds," testified Nadine Chabrier, Senior Policy and Litigation Counsel with the Center for Responsible Lending (CRL), at a recent hearing on the merger proposal. She noted that in deciding whether to approve a merger, government regulators, by law, must consider whether community needs would be served.

In an August 23 joint letter sent to the Office of the Comptroller of the Currency (OCC) and the Federal Reserve, agencies whose approval of the deal is required, consumer advocates made clear their opposition.

"This merger will result in a significant presence in the Southeast, in states like Tennessee, Texas, Arkansas, and Florida, among others, where there is a concentration of Black and Latino communities and poverty, often overlapping. These communities bear the acute and disproportionate burden of overdraft fees, calling into the auestion whether the needs and convenience of the community will be met," wrote the advocates. Elsewhere, they note, "Many affected by relentless overdraft fees end up having their checking account closed, and reentry into the banking system is difficult."

Signatories on the letter included: Americans for Financial Reform Education Fund, California Reinvestment Coalition, Demos, and CRL.

Federal regulators, appointed by the Biden Administration, have signaled scrutiny of mergers is a renewed priority.

Michael Barr, the newly appointed Vice Chair for Supervision of the Federal Reserve System, staked out this position as part of a wide-ranging September 7 speech titled, "Making the Financial System Safer and Fairer."

"Fairness is fundamental to financial oversight, and I am committed to using the tools of regulation, supervision, and enforcement so that businesses and households have access to the services they need, the information necessary to make their financial decisions, and protection from unfair treatment," noted Barr.

Here's hoping Mr. Barr and other regulators keep their word.

She made her a topic of conversation when she spoke about Teigen in a recent podcast when she blasted the model for bringing the abortion/miscarriage situation up when she spoke at the previously mentioned summit.

During her talk, she said she feels it was a "PR strategy" and that Teigen is addicted to social media as she calls her a "total psychopath." She goes on to state that this was done to make people forget about her cyberbullying scandal and to place her in a more positive light as "she's photographing herself going through a miscarriage."

Owens then says, "Chrissy Teigen, I guess who just cannot get enough social media, decided that she wanted to unearth that scenario and get more attention from it, so she initially said it was a miscarriage. She now says that the loss of her son Jack was the result of a life-saving termination—it actually wasn't a miscarriage."



Man threatens McDonald's patrons with axe in New York city



Man threatened several patrons with an ax at a Mc-Donald's in New York City on Sept. 16. The incident happened at approximately 2:25 a.m. on Delancey Street on Manhattan's Lower East Side.

Thirty-one-year-old Michael Palacios terrorized several patrons inside the restaurant following a physical altercation. Video footage taken at the scene showed Palacios as he argued with several patrons at the establishment.

After the altercation became physical and several people punched Palacios in the head, he took off his backpack and retrieved an ax. Palacios slammed the ax on a table before smashing a glass partition and hitting one patron in the head. After wielding the ax at several other patrons, Palacios left the McDonald's on his bicycle.

The video was posted on TikTok and Twitter where it quickly went viral. "@CrimeInNYC. NYC always good for some chaotic mayhem. He didn't hurt anyone, but it could have been ugly!"



"Upon arrival of officers, witnesses at the location reported that the suspect got into a physical dispute with three unknown males inside of the location," said a spokesperson for the Office of the Deputy Commissioner, Public Information. "The suspect removed an ax from his backpack and menaced the unknown males. The suspect intentionally caused property damage to the establishment. 

n an interview with TMZ, Wild 'N Out comedian Rip Michaels shared his own viewpoint of the events that took place behind the scenes which led to the alleged altercation between August Alsina and Tory Lanez.

"There was no fight, let's just be super clear there was no fight. I don't know why people say it's a fight, that was not a fight. He [Alsina] was sucker punched by Tory Lanez, so that's pretty much — yeah I was there."

Michaels continued, "It was straight like more of an assault type thing anyway." Due to Lanez's alleged vio-

Due to Lanez's alleged violent behavior, Michaels made an executive decision to cut the "Say It" singer from his "Fall Back In Love Comedy and Music Jam" tour, stating the vibe behind the tour surrounds unity and fellowship, two emotions Lanez has noticeably lacked after video footage showed Lanez with a few bodyguards follow Alsina after the



"Entanglement" singer ignored his handshake.

"At this moment, we have to proceed without him [Lanez] because we want to make sure that every person in that audience has a great time and great feeling and that same energy of each artist enjoying themselves and having a great time." Michaels said.

before and after their interaction. In the video, Lanez can be seen holding his hand out for Alsina to shake, to Lanez's apparent surprise, Alsina kept walking without acknowledging Lanez. This act prompted the "LUV" R&B singer to begin to walk in the opposite direction of Alsina before turning around with a group of men as they walked toward Alsina's direction.

Surveillance video shows Chaka Zulu (Ludacris' manager) was jumped before fatal shooting

s the Beacon previously reported, Chaka Zulu, who is the co-founder of record label Disturbing Tha Peace and longtime manager of Ludacris was recently arrested on murder charges. On Tuesday (September 13), he reportedly surrendered to police and bonded out on the same day.

Zulu, whose real name is Ahmed Obafemi, was arrested in connection to the June 26, 2022 shooting in the parking lot of his Buckhead, Atlanta, GA restaurant, Apt4B. In the incident, which "was a result of a dispute," Obafemi was one of three people shot and rushed to the hospital. The shooting left one person dead, a 23-year-old man named Artez Benton.

Zulu has also been charged with aggravated assault, possession of a firearm during the commission of a felony, and simple battery.

TMZ has obtained surveillance footage of the events leading up to the shooting and it shows a group of men, including Benton, in the parking lot of the restaurant. Zulu reportedly exchanged heated words with someone in



the group before he is jumped and beaten by the men. Chaka is the first to fire a weapon, striking Benton who later died from his injuries

All-white jury acquits officer who killed unarmed Black man

former Texas police officer was charged with shooting and killing Jonathan Price in October of 2020, per NBC News. Thursday he was acquitted of his murder charge after the jury found the officer's actions as reasonable. However...not one person on that jury was white. Price's family and their civil rights attorney Lee Merritt believe bias influenced the verdict.

There was not one person that looked like me. There was not one person that looked like my father. There was not one person that looked like Lee Merritt. Period," said Price's sister, Sabrina to NBC Dallas-Fort Worth.

Reports say former Wolfe City Officer Shaun Lucas confronted Price at a convenience store after receiving a call about a fight. Lucas thought Price was intoxicated and attempted to detain him. Price allegedly told the cop, "I can't be Lucas innocent."



detained," and the two struggled while Lucas tried to restrain him. Per the affidavit, Lucas deployed a stun gun on Price as he walked away but Price tried to reach out and grab the end of it from Lucas' grasp. This prompted the officer to fire four times at Price's upper torso. He died in the hospital.

Initially, Lucas was fired after Texas Rangers found his actions "were not objectively reasonable" in a preliminary investigation. However, even after finding Price was non-threatening at the time of the shooting, the jury found

Bus driver caught on video shoving Black siblings arrested, charged

he mother of two Georgia children who a school bus driver assaulted is calling for harsher penalties for the man who abused them.

Nequania Carter believes James Ö'Neil received a "slap on the wrist" from authorities after he was caught on video shoving her two children who were under his care on a school bus earlier this month. She also thinks the crime was racially motivated, but investigators said they "could not establish a nexus" to support her claim.

O'Neil was arrested for two counts of simple battery on Friday, Sept. 16. The district fired him shortly after the incident. Simple battery is a misdemeanor with a penalty of up to one year in prison. Because O'Neil committed the crime as an employee, it could be escalated to a high or aggravated nature, which means he could be subject to a \$5,000 fine instead of \$1,000.

The charges are enough to say, 'we did something, so now they can ease up on it," Carter told Atlanta Black Star. "No, it is not enough."

O'Neil is seen in the viral video pushing Carter's 6-year-old on Sept. 9 before his sister intervenes. The driver then tells the 10-year girl to return to her seat and later threatens to take her phone. Carter said the driver wanted the boy to sit in the back, but that area is reserved for high school students. At one point, the small boy who was shoved over in the seat appeared frantic.

The children's parents have since removed them from the mostly white Morgan County school system and placed them in a more diverse school district.

Morgan County Chief Deputy Keith Howard said the investigation into the incident "was complicated by the allegation that the incident was perceived as being racially motivated." Texas city settles lawsuit over mother's arrest captured on video

FORT WORTH, Texas (AP) — A Texas city has settled a federal civil rights lawsuit filed by a Black mother after she and her daughter were wrestled to the ground and arrested by a white police officer following a dispute with a neighbor.

City of Fort Worth officer settles lawsuit from Jacqueline Craig for \$150,000, pending City Council approval

Jacqueline Craig and one of her daughters were wrestled to the ground and had a stun gun pointed at them by Fort Worth officer William Martin in December 2016. Another of Craig's daughters, who filmed the incident on her cellphone, was also arrested.

Charges against all three were later dropped. Martin served a 10-day suspension for violating departmental policies.

The city agreed to settle the lawsuit for \$150,000, the Fort Worth Star-Telegram reported Friday. The settlement is pending City Council approval.

As part of the settlement, the city admits no other fault and there are no other requirements, a Fort Worth spokesperson said. Craig has alleged the neighbor grabbed and choked her young son after seeing him litter. Craig and the neighbor both called

The passing of the British Empire

- Queen Elizabeth II's death at 96 has occasioned an outpouring of tributes and grieving across the world. Heads of state, including Joe Biden, mourn her passing. Common citizens have built mountains of flowers at her gate. The British football league even postponed its games for a weekend in her honor. Crowned queen in 1953 at

the face of the British Empire, of the world's territory. the head of not just a nation but a global empire which devolved into a global commonwealth. From her corgi dogs to her wardrobe choices to the family squabbles a fixture – a symbol of stability in times of trouble.

Her commitment to her duties – however ceremonial – was praiseworthy. While as Queen in Britain her political opinions and preferences are by tradition masked, peoples across the world saw her as a source of solace and of concern. Even the reports of the racial tensions within the royal family did not disrupt that image.

Yet while we mourn the passing of the Queen, we should not mourn, as Harvard historian Maya Jasanoff has written, the passing of the British Empire.

"The sun never sets on the British Empire" was once literally true. At its height in the early 1900s, the tiny British island ruled over 412 million people, nearly one-fourth of the world's population at the age 25 in the wake of World War time, and over 13.7 million square

Imperial nostalgia paints this as a picture of "white man's burden," the civilizing force of Britain benignly ruling over its subjects. In fact, 65 countries have to date and scandals, Queen Elizabeth was claimed independence from Britain – and many of these only after brutal resistance from the British. The first of the many revolutions against the empire was that of the American colonies. Our Declaration of Independence declared independence from the British crown, after detailing "a history of repeated injuries and usurpations, all having in direct object the establishment of an absolute Tyranny over these States." Our independence was achieved only by force of arms.

Britain's empire included many settler nations – like South Africa and Australia – that savaged indigenous populations to take their lands, their minerals and jewels, and too often their people.

In Malaya, Kenya, Cyprus, Yemen, Nigeria, Ireland and more, popular independence movements were met with violent sup-II, Queen Elizabeth II served as miles of territory, nearly one-fourth pression, mass arrests and often the reality of the past is part and past, and creating a new future.

torture. In many cases, Britain invented the tactics that Americans grew to know - from counter-insurgency campaigns to detention camps, to systematic torture.

Even with the Queen presiding over the Commonwealth of Nations, 56 states largely former territories of the British Empire, a slow reckoning of this past has begun. In 2013, Kenyan victims of torture won a lawsuit providing them with damages. In 2019, survivors from Cyprus achieved the same. Calls for reparations or for at least official investigation and apology for the horrors abound.

Just as U.S. school boards and legislatures struggle with how to deal with its legacy of slavery in textbooks, in official statutes, in public monuments - so too Britain now wrestles with how to think about and teach its history. Just as there has been a fierce reaction here, so too in Britain, xenophobes demand a continued whitewashing of the history of violence, oppression and economic exploitation.

In fact, coming to grips with

partial of changing to meet the challenges of the modern day. The Britain that once ruled much of the world now struggles to rule itself. With Brexit, it has left the European Union. With the growing movement toward Scottish independence, it faces dissolution within. It is heading into the worst economic crisis in decades – even as inequality reaches ever more obscene extremes, yet its financial center – the City of London – looks abroad not at home for its investments. Demagogues call upon the mythic past while failing to deal with the current grim realities. What is needed is a politics that brings people together in a national project of renewal. Imperial nostalgia, global adventure, the dominance of the financial elite stand in the way.

Queen Elizabeth II garners praise for her grace, her discipline, her commitment. Her passing should mark not only the end of an age, but the end of a delusion. Britain will not be made great again by looking backward, but only by understanding the reality of its



Rihanna will perform at Super Bowl LVII

he NFL just landed what's likely to be its most anticipated Super Bowl halftime performer since Janet Jackson. Most anticipated because the marquis entertainer for the February 2023 show is Rihanna, an artist who still ranks as one of the most popular singers in the world who also hasn't given a concert in nearly five years.

Pope Francis appeals for release of Catholics kidnapped in Cameroon

(GIN) -

ope Francis has added his voice to calls by the bishops of Cameroon for the release of five priests, a religious sister, a cook, a catechist and a 15 year old girl kidnapped in southwest Cameroon where a civil war has been raging between the French and English-speaking communities for years.

At a mass on Sept. 25, the pope said he was praying for peace in Cameroon. "I join in the appeal of the bishops of Cameroon for the liberation of people kidnapped in the diocese of Mamfe," according to the Catholic News Agency.

In addition to the kidnappings on Sept. 16, gunmen set fire to St. Mary's Catholic Church in Nchang, Cameroon, according to Vatican News

Catholic bishops in Cameroon strongly condemned the attack in a statement that called for the immediate release of the kidnapped Christians.

'We insist on this because this act has now crossed the red line and we must say that 'enough is enough," they said in the statement

The roots of the current Anglophone problem can be traced back to the First World War when the British and French occupied the "German Kamerun Protectorate" and divided its territory into two parts. This partition gave rise to the development of a different cultural heritage and identity in the British and French regions, a

development that would create problems for future attempts at reunification.

In 1961, the U.N. held talks to determine whether the British territory should be annexed to Nigeria or Cameroon. Critics labeled the talks "false negotiations" involving parties with asymmetrical powers.

"As the British Southern Cameroons'nationalist conflict continues to wax and wane, the people of former British Cameroons live with a sense of deception in the present-day République du Cameroon," wrote scholar Fonkem Achankeng in the Journal of Global Initiatives.

The proportion of Anglophone Cameroonians to French-speakers is currently at around 16%, down from 21% in 1976.

Attacks on the church were also denounced by the Centre for Human Rights and Democracy in Africa (CHRDA)-an independent, non-governmental, apolitical and non-profit making organization dedicated to the protection and advancement of human rights.

In a related development, the rights watchdog, Human Rights Watch, reports the re-arrest of prominent Cameroonian Anglophone peace activist Abdul Karim Ali. He is accused of possessing a video on his phone showing alleged human rights abuses committed by a Cameroonian soldier against civilians in the country's English-speaking regions. w/pix of Church of St. Mary's Nchang



Church of England bars Tutu's daughter from funeral

he daughter of the late Archbishop Desmond Tutu said she was "stunned" by the Church of England when they denied her the right to officiate at her godfather's funeral because she is married to a woman.

According to the Rev. Mpho Tutu van Furth, an Anglican priest in the Diocese of Washington, DC, the Church barred her from officiating despite her late godfather's personal wish that she lead the . ceremony at his funeral.

Her godfather, Martin Kenyon, died in England last week. He was 92.

"You can't speak a message of welcome and love and live a message of exclusion," the Rev. Tutu van Furth said. "It's incredibly sad," she told BBC News. "It feels like a bureaucratic response with maybe a lack of compassion."

Martin Kenyon and Desmond Tutu became friends when they were both students at Kings College. Tutu would become a voice for LGBT equality, speaking in a video released by the Free & Equal campaign.

"I cannot keep quiet when people are penalized for something about which they can do nothing," Tutu declared. "First, when women are excluded just simply and solely because they are women. But more pernicious, more ghastly is the fact that people are penalized, killed, all sorts of ghastly things happen to them simply because of their sexual orientation.

"I oppose such injustice with the same passion that I opposed apartheid.

Mr. Kenyon, a powerful force in the anti-apartheid movement in South Africa, was also an early, outspoken critic of the Anglican Communion's stance on gay rights.

However, its sister Anglican church in the US, The Episcopal Church, does allow clergy to enter into gay marriages.

Marceline Tutu van Furth, a Dutch academic who is married to the Archbishop Tutu's daughter, said the church told them it accepts priests in same-sex relationships but not if they are married.

The Church of England and the Episcopal Church are tied together in the global Anglican Communion, which represents about 85 million worshipers around the world. The Episcopal Church has

taken a stance in favor of acceptance of gay clergy and members, starting with the consecration of Bishop Gene Robinson, an openly gay priest, in New Hampshire in 2003.

The Church of England, however, has said that under its religious laws, while it permits same-sex civil partnerships, it does not support same-sex marriage because it would go against its teachings. Gay clergy are expected to remain celibate, and those in same-sex marriages are not permitted to be ordained.

Tutu remarked in 2013: "I would refuse to go to a homophobic heaven. No, I would say sorry, I mean I would much rather go to the other place. I would not worship a God who is homophobic and that is how deeply I feel about this."

He added: "I am as passionate about this campaign as I ever was about apartheid. For me, it is at the same level."

In the end, Tutu was able to fulfil her godfather's wish as the service was moved from a church and was instead held in her godfather's garden in Shropshire. w/pix of Archbishop and daughter




